- 1. The Company had provided the remote e-voting facility offered by NSDL (National Securities Depository Limited) to the shareholders of the Company.
- 2. In accordance with the Notice of 36th Annual General Meeting dated 26th September 2017 sent to the shareholders and the "Advertisement" published pursuant to the Rule [20(3)(v)] of the Companies Management and Administration) Rules, 2014 & amendment thereof on 2nd Day of September, 2017 in 'Business Standard' in English and in Hindi.
- 3. The shareholders holding shares either in physical form or in dematerialized form as on the "cut off" date i.e. Tuesday, the 19th September were entitled to vote on the proposed resolution(s) item no. 1 to 5 as set out in the Notice of the AGM of Euro Asia Exports Limited by remote e-voting or voting through polling paper at AGM.

- 6. After the time fixed for closing of the poll by the Chairman, One ballot box kept for polling were locked in my presence with due identification marks placed by me,
- 7.
